- Westampton Land Development Board Meeting Bryan O'Neal mentioned that the LDB Meeting to discuss the proposed warehouse on Springside Road was postponed to May 3<sup>rd</sup>. All Westampton residents should attend this important meeting regarding warehouse development in the township.

 Burlington County Senior Expo – Bryan O'Neal mentioned that the Burlington County Senior Expo is to take place on June 14<sup>th</sup> at the Masonic Home in Burlington Township. Additional information on this Expo has been posted on the Fernbrooke's website.

#### **OLD BUSINESS**

- O RFP# 23-01 Tree Removal & Cleanup (Hedgerow) Ralph Hendrickson mentioned that this Project has been delayed due to a contractor (Cornerstone) that keep delaying the work and the Board decided to go with the second contractor (Hyperion) which will start on or about May 1<sup>st</sup> to remove and cleanup the dead trees and branches from the east side hedgerows. Hopefully, the west side hedgerows cleanup will start in late fall or early winter timeframe.
- RFP# 23-02 Tree Pruning & Trimming (Common Areas)
   Ralph Hendrickson mentioned that this project will coincide with the Tree Removal & Cleanup Project by Hyperion Tree Services.
- RFP# 23-03 Community Management Services
   Bryan O'Neal mentioned that the Board received three proposals for Community Management
   Services and decided to grant APM a one year contract from 05/01/2023 thru 04/30/2024.

#### **NEW BUSINESS**

- RFP# 23-04 Circle Garden Bed Renovations
   Bryan O'Neal mentioned that the Circle Garden Bed will go thru a minor renovation by replacing the brick pavers with either plants or gravel.
- RFP# 23-05 Trees & Shrubs Landscaping (Phase I)
   Ralph Hendrickson presented the trees and shrubs landscaping plans to the community and mentioned that the Association will be going out to bids shortly.
- RFP# 23-06 Pond Mapping & Analysis Services
   Bryan O'Neal mentioned that the Association will be going out to bids to have the pond mapped and analyze to determine how deep the pond is and how much sediment is on the pond's bottom. This information will be beneficial in determining when the pond will need to be dredged. This service will be conducted in late fall.
- RFP# 23-07 Landscaping & Snow Removal Management Services
   Bryan O'Neal mentioned that the current contract with A&M ends in November and the Association will be going out to bids for landscaping and snow removal services.
- RFP# 23-05 Entrance Pavers Drainage Issue
   Bryan O'Neal mentioned that the Association will be going out to bids to have the sunken pavers at the entrance remove, fix base, and reset pavers.

The meeting was opened to the attending homeowners for questions & comments.

**John McCarty (40 Mayfaire)** – Asked on the status of 44 Mayfaire. He mentioned that the home is shabby and wanted to know what the bank is going to do to clean up the property.

Tina Johnson – Had recent communication with a new bank that has taken over the property at 44 Mayfaire and will sent them information on what needs to be done to the exterior. Tina Johnson mentioned that the banks are overwhelmed with foreclosed properties and that it takes time to legally settle and put on the market.

**Ralph Hendrickson** - Since no other public comments, the open meeting for public comments has been closed.

Ralph Hendrickson commented that he appreciates the effort that each of the homeowners has made thru the years to keep their properties nice and understands the concerns from John McCarty regarding 44 Mayfaire.


