- RFP# 24-01 Entryway Pavers Reconstruction Project
 A&M is scheduled to start this project the week of July 29th. They will close down the entrance side for 7 10 days follow by the exit side.
- O RFP# 24-02 Trees & Shrubs Landscaping (Phase II) Project

We issued a Request for Proposal (RFP) to five landscaping vendors and received two bids, with Flagg's Landscaping & Garden Center providing the most competitive offer.

NEW BUSINESS

○ Geese Issue - Resolution

The Board presented the installation of an additional, low-cost fence barrier to prevent geese from passing under the existing fence and onto the sidewalks. The barrier will be situated on the pond side, not the sidewalk side, with an estimated cost of \$726.00.

Road Signs Replacement

The Board is currently seeking pricing for community road sign replacements, comprising seven 'Stop' signs, twenty-two 'No Parking This Side' signs, and one 'Do Not Enter' sign. As outlined in the community's Governing Documents, Fernbrooke is responsible for road sign maintenance. The Board will facilitate the procurement and installation of replacement signs, anticipating completion in September or October.

OPEN MEETING for PUBLIC COMMENTS

The meeting was opened to the attending homeowners for questions & comments.

Q. Celeste Diehl (32 Mayfaire) – Has a suggestion regarding inspection notices, once the violations have been completed and reported to APM, it would be nice to receive an acknowledgment back to the homeowner specifying that the property has been re-inspected.

A. Ellen Woeller – Will follow-up with the homeowner with either a letter or email to notified them that the re-inspection has been satisfied.

Q. Betty Devlin (21 Mayfaire) – Has a question pertaining to tax exemption for Fernbrooke. She believes that she read somewhere that because we are an organization that we are tax exempted.

A. John Caruso presented a document "Nonprofit Organizations and Government Entities" from the New Jersey Division of Taxation that specifies that homeowner associations do not qualify for exemption.

Q. Betty Devlin (21 Mayfaire) – The Budget for some reason is showing \$2,000 for "Pet Station Maintenance".

A. Ellen Woeller explained that the new Vantaca system changed the G/L Accounts and that it has already been corrected for Fernbrooke.

Q. Betty Devlin (21 Mayfaire) – Regarding lawn care, due to dry conditions, can we expect a service reduction since personnel are walking around with equipment off? She possesses video evidence indicating incomplete work while full payment is being rendered.

A. Ellen Woeller will reach out to Mike at A&M regarding this matter.

The meeting was closed to the attending homeowners for questions & comments.

COMMENTS FROM THE BOARD

Ralph Hendrickson stated that the Board will diligently strive to identify solutions to the issues posed by the geese and take reasonable measures to mitigate the presence of goose droppings on sidewalks.

He also encouraged everyone to make a concerted effort to attend the community event scheduled for September.
